NOTICE OF PUBLIC HEARING TOWN OF ONONDAGA

NOTICE IS HEREBY GIVEN that public hearings will be held by the Town Board of the Town of Onondaga, Onondaga County, New York, at the Town Hall located at 5020 Ball Road in said Town, on November 7, 2024, commencing at 7:00 p.m. or as soon thereafter as the matter can be heard, for the purpose of replacing existing contracts with certain volunteer fire department corporations in the Town of Onondaga as set forth in Schedule "A" attached hereto, which said contracts were due to automatically renew on January 1, 2025, in accordance with the provisions of Section 184 Subdivision 4 of the Town Law of the State of New York, providing for fire protection and emergency services to be furnished by said corporations to certain fire protection districts (hereinafter "districts") established in said Town of Onondaga and also set forth on Schedule "A" upon the following general terms:

- 1. The fire departments and apparatus of said corporations shall answer and attend upon all calls in their respective fire protection districts.
- 2. The districts shall be responsible for payment of all claims for injuries or death of firemen in connection with such calls.
- 3. For such services rendered by the fire departments, said corporations shall receive the annual sum as set forth in Schedule "A".
- 4. Said contracts shall be for the calendar year of 2025 and shall thereafter be subject to automatic renewal in the manner provided by Section 184, Subdivision 4 of the Town Law of the State of New York, however, the terms of such contracts, including renewals, shall not exceed three (3) years.
- 5. For such other incidental terms as may be necessary or proper in connection with such contracting.

The reason why the existing contracts in Schedule "A" are to be terminated and replaced

with new contracts is to increase the amount to be paid for services from the annual sums stated in

the existing contracts to greater sums as set forth in Schedule "A" in order to enable the said

corporations to more adequately provide full fire protection and emergency services within the

said fire protection districts.

All persons interested in these matters shall be heard at such time and place.
